




Spotlight: NCLEJ and Colleagues Achieve Speedier Payment of Food Stamps to Low-Income Hawaiians

Food stamp recipients in Hawaii are getting their crucial benefits even faster as the result of the final settlement in *Booth v. McManaman*, a federal class action. This case has already

achieved a substantial improvement in agency performance, with thousands more low-income households receiving food stamps promptly, and the settlement requires further improvement in benefit processing times. NCLEJ joined Hawaii Appleseed Center for Law and Economic Justice and Alston Hunt Floyd & Ing as counsel in this case.

Spotlight: NYC Housing Authority Agrees to Fix Rampant Mold and Moisture Problems

The New York City Housing Authority will address mold and excessive moisture in its apartments more quickly and thoroughly as a result of an agreement in a federal lawsuit filed by NCLEJ and the Natural Resources Defense Council on behalf of people with

asthma living in public housing. Excessive moisture in NYCHA housing, home to 400,000 New Yorkers, has led to rampant and severe mold problems. Residents with asthma are particularly vulnerable to the ill effects of mold and moisture. Under the terms of the agreement, for the first time, NYCHA will be required to respond to mold and moisture complaints within strict time frames depending on the severity of the condition.
