### NCLEJ Challenges Unconstitutional Revocation of Driver's Licenses in Tennessee



NCLEJ, along with cocounsel Civil Rights Corps, Just City, and the law firm of Baker Donelson, has filed *Thomas v. Haslam*, a

federal class action lawsuit challenging the unconstitutional revocation of driver's licenses — without notice or opportunity to be heard — from more than 146,000 low-income people in Tennessee who are too poor to pay criminal justice debt.

In Tennessee, as in many jurisdictions, defendants in the criminal justice system incur substantial debt, as they are charged with the costs of their own prosecution.

Tennessee law requires that people must pay these costs within one year or suffer the mandatory revocation of their driver's licenses. Without their driver's licenses, people have difficulty getting and keeping work, accessing medical care, and even engaging in simple activities of daily life like grocery shopping and visiting friends and family. that have resulted in significant reductions in Medicaid services for adults with severe developmental disabilities.

Michigan receives federal funding under a Medicaid waiver to assist people with developmental disabilities with critically needed activities of daily living necessary to allow them to live in their own homes, or in a community supported living arrangement setting. For fiscal reasons, the defendant county agency reduced the individually allocated budgets for the plaintiffs that allow their guardians to pay caregivers to deliver medically necessary services in the home. As a result, they have been placed at significant risk of being uprooted from their homes and institutionalized. Read more.
